Postgraduate Legal Fellowship, Philadelphia

The Education Law Center seeks to sponsor applicants for postgraduate legal fellowships to start in the Fall of 2020. Applicants should be law students graduating in the Spring of 2020 or current law clerks. Applicants should have a demonstrated commitment to public interest law, ideally with experience working with vulnerable populations.

The Education Law Center's mission is to ensure access to a quality public education for all children in Pennsylvania. We pursue this mission through advocacy on behalf of the most vulnerable students — children living in poverty, children of color, children in the foster care and juvenile justice systems, children with disabilities, English Learners and immigrant children, LGBTQ students, and children experiencing homelessness. ELC has three priority program areas which often intersect: ensuring equal access to school, advocating for fair school funding, and dismantling the School-to-Prison Pipeline.

ELC engages an array of strategies to fulfill our mission including policy advocacy, impact litigation, community engagement, and direct representation. Our work includes direct client contact, case development, formal representation in state and federal court, and advocacy with local school districts and state legislative and administrative bodies.

Scope and responsibilities of the fellowship will vary depending on the project and sponsor/funder priorities. Potential projects under consideration include the following:

- Reducing education barriers facing students involved in the juvenile justice or foster care systems
- Representing students experiencing bullying or harassment in schools and pursuing policy advocacy to require effective investigations and interventions in schools
- Reducing education barriers and promoting effective models for students who need mental health and behavioral health supports in schools
- Engaging in research and policy advocacy to promote equity in public charter schools

All ELC attorneys, including fellows, participate to some degree in the work of the office including:

- Supporting ELC's direct representation work through handling intake calls with clients
- Supporting ELC's litigation and policy advocacy through legal research and writing

Qualified applicants should have a J.D. and:

- Strong interpersonal and communication skills
- Strong analytical, critical thinking, and problem-solving skills
- Strong legal research and writing skills
- Commitment to social justice
